WAIVER, ASSUMPTION OF RISK, PERMISSION SLIP, MEDICAL RELEASE, AND ACKNOWLEDGEMENT OF EXPECTATIONS

I (We) acknowledge that my child's participation in Port Huron First Church of the Nazarene's (referred to as First Church for the rest of this document) activities is voluntary and may require traveling or physical exertion. Such activities may include, but are not limited to: outings, athletic games, local excursions and meetings, cook outs, boating, water-skiing/tubing, canoeing/kayaking, swimming, basketball, roller skating, rollerblading, games in the park, soccer, paintball, broomball, ice-skating, volleyball, softball, baseball, camping, downhill skiing, snow-boarding, snow-tubing, hiking, biking, concerts, Bible studies, golfing, miniature golfing, hayrides, and other common group games. I (We) acknowledge that my child's participation in any First Church youth activity presents risks that I or my child may suffer including, but not limited to, damage to personal property, financial damage, emotional injury, illness, bodily injury, or death. I (We) hereby assume those risks. And, in consideration of my child's being allowed to participate in the First Church youth program activities, I (We) agree and take the following actions for me and my child:

I (We) waive, release, and discharge First Church, its pastors, directors, officers, members, employees, volunteers, representatives, subcontractors, and agents from any and all claims for: (A) Financial losses, including (but not limited to) insurance deductibles and medical expenses, that we as parents or guardians must pay as a result of injury or illness arising out of activities sponsored by First Church; (B) Damage, destruction, loss or theft of personal belongings of the minor participant or parents of the same; and (C) Any claims or liabilities that I (We) may assert as parents for loss of consortium, death or personal injury, which arise out of or relate to my child's participation in First Church's youth activities; and, to the extent allowable by law, all similar or identical claims that my child may assert. Notwithstanding any of the foregoing, First Church is not released from any claims or liabilities that are caused solely by First Church.

I (We) agree not to sue any of the persons or entities mentioned above for any of the claims or liabilities that I have waived, released, or discharged herein.

I (We) indemnify and hold harmless the person or entities mentioned above from any claims made or liabilities assessed against them as a result of my child's actions.

I (We) agree to indemnify and hold harmless the persons or entities mentioned above for any claims or liabilities assessed against them as a result of any inaccuracy of the information that I (We) have provided on this sheet, or the insufficiency of my legal capacity or authority to act for and on behalf of the minor in the execution of this form.

I (We) do consent, in the event that my child is injured and requires the attention of a doctor or dentist, to any reasonable medical treatment as deemed necessary by a licensed physician/dentist. In the event treatment is required from a physician/dentist and/or hospital personnel designated by First Church, I (We) agree to hold such person free and harmless of any claims, demands, or suits for damages arising from the giving of such consent. I (We) also acknowledge that we will be ultimately responsible for the cost of any medical care should the cost of that medical care not be reimbursed by

my (our) health insurance provider. Further, I (We) affirm that the health insurance information provided above is accurate at this date and will, to the best of my (our) knowledge, still be in force for the youth named above. I (We) also agree to bring my (our) child home at my (our) own expense should they become ill or if deemed necessary by the student ministries staff member.

I acknowledge and will comply with these rules of conduct expected from each youth, parent, and adult volunteer:

- Respect one another, staff, and the adult leaders
- Respect property
- No lighters, fighting, weapons, fireworks or other explosives
- No students permitted to drive other students without express permission from both sets of parents/guardians
- Participation with the group is expected
- No offensive or immodest clothing (includes swimwear and workout gear)
- No possession or use of alcohol, illegal drugs or tobacco
- No boys in girls sleeping areas and vice versa
- Respect and comply with event schedules (BE ON TIME)

I (We) and my child acknowledge that misconduct may result in transportation home from any activity at the parent's expense. A student dismissed for a disciplinary reason will not receive a refund of ANY activity fee. My (our) child and I (us) agree to follow the instruction of the pastor, leader, or volunteer who has been delegated leadership authority.

I (We) understand and authorize that my child's image may be photographed or filmed and used in First Church video presentations, printed publications, web site and photo directories.
